### Summary

Rita Bencivenga's general research interests are in gender in higher education, gender and technology, equality, diversity and inclusion (EDI), lifelong learning. Since February 2021 she is a member of the Ulyseus University TEAM, at the University of Genoa. She collaborates also at the following EU funded projects: GenderEX: Gender for Excellence in Research and MILIEU, Women, Disability and Inclusion- Scientific Excellence in Bulgaria.

She contributed to creating the UniGE and Municipality of Genoa's Gender Equality Plans, and she gives speeches and training in Universities and Public Bodies on how to build, manage and monitor GEPs in a gender+ perspective and adding a gender dimension to research and teaching activities. She is an EDI expert and practitioner.

Rita Bencivenga graduated in Educational Sciences from the University of Genoa, Italy. After a successful career in the private and non-profit sectors managing international projects on higher and adult education, with a focus on technology, she completed her PhD in educational Sciences at the University of Paris X, Nanterre, France, under the supervision of Cendrine Marro and Nicole Mosconi. She worked at TCGEL, Trinity Centre for Gender Equality and Leadership, from September 2018 to September 2020. Her research activities at TCGEL focused on Feminist Institutionalism and Gender Equality in Higher Education and ICT Companies. During her stay she gained considerable knowledge in Athena SWAN.

She has been Visiting Research Fellow at the School of Politics, International Studies and Philosophy at Queen's University Belfast, Northern Ireland, UK. In France, she is a member of LEGS - Laboratoire d'études de genre et de sexualité. CNRS/Université Paris 8 Vincennes Saint-Denis et Université Paris Ouest.

From 2015 to 2018, she taught undergraduate, graduate and master courses at ISPEF, Institut des Sciences et Pratiques d'Éducation et de Formation, Université Lumière Lyon 2, France. She collaborates with Since 1993 she has been appointed regularly as an expert for Project reviews, assessments, and evaluations for the European Commission.

Rita Bencivenga has considerable expertise in qualitative research, and in coordinating qualitative research activities in different languages. She has worked in consortia and as a partner project manager for more than 30 international projects financed by the EU, on gender and ICT, discrimination issues (sexism, heterosexism, ageism, disablism), including intersectionality (ADAT and UAV EU projects), adult non-formal and informal education, all of them concluded successfully and with a significant impact at local and international level.
